Specialized Infant/Toddler Rate for Family Day Care:

To encourage smaller group sizes for infants and toddlers, a special rate will be paid to registered family day care providers who are registered to care for 6 or fewer children. The special rate is available for children in care under age 3. Providers can be reimbursed up to a maximum of 25% above the established county rate for this age category as long as the final rate does not exceed what the provider currently charges the general public.

Example (using Minnehaha County):

Specialized Infant/Toddler Maximum Reimbursement Rate Payable: \$3.20 per hour
 $\$3.20$ (established county rate) + 25% = \$4.00 per hour

If the provider charges the general public \$4.20 per hour, the provider is reimbursed at \$4.00 per hour.

If the provider charges the general public \$3.50 per hour, the provider is reimbursed at \$3.50 per hour.

Special Needs Rate: \$5.80 rate ceiling - all ages, all counties

Providers caring for a child with special needs can be reimbursed up to this maximum rate. In some instances, a higher rate for the care of a child with special needs can be negotiated. Contact the Division of Child Care Services at 1-800-227-3020 for additional information.
