## INTRODUCTION

The Annual Synar Report (ASR) format provides the means for States to comply with the reporting provisions of the Public Health Service Act (42 U.S.C. 300x-26) and the Tobacco Regulation for the SAPT Block Grant (45 C.F.R. 96.130 (e)).

Public reporting burden for the collection of information is estimated to average 15 hours for Section I and 3 hours for Section II, including the time for reviewing instructions, completing and reviewing the collection of information, searching existing data sources, and gathering and maintaining the data needed. ### **How the Synar report helps the Center for Substance Abuse Prevention**

In accordance with the tobacco regulations, States are required to provide detailed information on progress made in enforcing youth tobacco access laws (FFY 2011 Compliance Progress) and future plans to ensure compliance with the Synar requirements to reduce youth tobacco access rates (FFY 2012 Intended Use Plan). These data are required by 42 U.S.C. 300x-26 and will be used by the Secretary to evaluate State compliance with the statute. Part of the mission of the Center for Substance Abuse Prevention (CSAP) is to assist States<sup>1</sup> by supporting Synar activities and providing technical assistance helpful in determining the type of enforcement measures and control strategies that are most effective. This information is helpful to CSAP in improving technical assistance resources and expertise on enforcement efforts and tobacco control program support activities, including State Synar Program support services, through an enhanced technical assistance program involving conferences and workshops, development of training materials and guidance documents, and onsite technical assistance consultation.

### **How the Synar report can help States**

The information gathered for the Synar report can help States describe and analyze substate needs for program enhancements. These data can also be used to report to the State legislature and other State and local organizations on progress made to date in enforcing youth tobacco access laws when aggregated statistical data from State Synar reports can demonstrate to the Secretary the national progress in reducing youth tobacco access problems. This information will also provide Congress with a better understanding of State progress in implementing Synar, including State difficulties and successes in enforcing retailer compliance with youth tobacco access laws.

## **Where and when to submit the Synar report**

The Annual Synar Report (ASR) must be received by SAMHSA no later than December 31, 2012. The ASR must be submitted in the **approved OMB report format**. Use of the approved format will avoid delays in the review and approval process. The chief executive officer (or an authorized designee) of the applicant organization must sign page 1 of the ASR certifying that the State has complied with all reporting requirements.

The State must upload one copy of the ASR using the online WebBGAS (Block Grant Application System). In addition, the following items must be uploaded to WebBGAS:

- **FFY 2012 Synar Survey Results:** States that use the Synar Survey Estimation System (SSES) must upload one copy of SSES Tables 1–5 (in Excel) to WebBGAS. States that do not use SSES must upload one copy of ASR Forms 1, 4, and 5, and Forms 2 and 3, if applicable, (in Excel) to WebBGAS.
- **Synar Inspection Form:** States must upload one blank copy of the inspection form used to record the result of each Synar inspection.
- **Synar Inspection Protocol:** States must upload a copy of the protocol used to train inspection teams on conducting and reporting the results of the Synar inspections.

The Division of Community Behavioral Health will continue to monitor compliance in accordance with the regulations and will explore opportunities to work with law enforcement and State Attorneys' offices to provide consistency with penalties, fines, etc. The Division of Community Behavioral Health will explore opportunities to partner with community-based coalitions to increase education regarding environmental strategies impacting tobacco access issues. The Division also has staff participating with the Department of Health in development of a Youth Access strategic plan.

The geographic structure of the state can be challenging, as there are many miles to cover. There is a shortage of resources associated with law enforcement and funding. However, even with the challenges, South Dakota's rates have remained within guidelines, and the state will continue to explore opportunities to further reduce the rate. The Division continues to pursue collaborative efforts with the Department of Health and Attorney General's office to strategize efforts to focus on reduction and enforcement efforts.

- Column 7: Form 2 (in Excel form) will automatically calculate the stratum RVR for each stratum in this column. The State is divided into seven balanced strata based on the existing identified geographic boundaries of the seven judicial circuits in the State. Each over the counter outlet in each stratum has a random chance of being selected for the Synar sample each year. In addition to providing a relatively balanced grouping of tobacco outlets, utilization of the existing seven (7) Judicial Circuits provides the benefit of geographic proximity for survey administration as well as easing communication with States Attorneys and other legal officials. In addition, based on the recommendation of CSAP, South Dakota has created a specific and separate stratum (stratum 8) inclusive of vending machines only.

South Dakota will also select a random reserve sample. The purpose of the reserve sample is to provide an additional pool of outlets to inspect when an ineligible outlet is encountered during the inspection process in order to attain an appropriate sample size as planned in each stratum. The reserve sample will be selected using the same sampling methods as for the original sample list. Simple random sampling (SRS) is applied to select outlets for the original sample list in each stratum. Then SRS is applied again to select outlets for the reserve list from the remaining outlets (after taking out the original sample list) in each stratum. The

sample size for the reserve list will be about one-half of the sample size of the original sample outlet. For example, if the original sample size for Stratum 1 is planned to be 100. After randomly selecting 100 outlets for the sample list, an additional 50 outlets are randomly selected for the reserve sample for Stratum 1. Depending on the size of the stratum, it is possible that all of the remaining outlets may be selected for the reserve list. All of the sampling procedures will be performed using statistical software. Inspectors encountering an ineligible outlet during the inspection process are instructed to select the first outlet from the reserve sample as a replacement and so on for the next ineligible outlet encountered.
