Trainings

Who can register?

Training prerequisites are listed in purple next to the training name. Specific contracted providers may be given priority based on the specific services they are contracted for. Additional providers may be considered dependent on the demand from qualifying agencies. Registrants must be available to attend the entire training with no planned absences and in-person when applicable.

How will I find out when registration opens if it's not posted?

Training details and registration information is updated on the website as it becomes available. Additionally, announcement emails are sent to our listservs which include agency leadership. Agency leadership shares this information with their staff as appropriate.

The PESI training library and MRT training registration is open through the end of May 31st, 2026.

What is the cost of training?

Trainings posted on the Provider Hub are available at no cost for contracted providers that meet the prerequisites. Travel expenses such as lodging, food, and gas are the responsibility of the agency.

Why is the registration link not working?

The training may be at capacity causing the form to close. You may email DSSQATraining@state.sd.us to be added to the waitlist.

How do I cancel my registration?

Please email DSSQATraining@state.sd.us as soon as possible to allow time for a waitlisted participant to register.

Job Board

A public job board for South Dakota-based behavioral health positions is available at sdbehavioralhealthcareers.sd.gov/job-board. This job board is currently exclusive to positions within the publicly funded network.

Agencies may submit their open position to be posted utilizing the form at the bottom of the Provider Hub. Submissions will be posted within 3 business days at the discretion of the Division of Behavioral Health. They may also be included in our workforce newsletter as appropriate.
