History of Appropriate Regional Facilities in South Dakota

During the 2020 Legislative Session <u>SDCL 27A-10.1.2</u> passed allowing other types of providers to seek designation and provide services as ARFs.

During the 2021 Legislative Session, Senate Bill 144 and 186 passed to support behavioral health crisis stabilization.

- SB 144
- SB 186

As a result of the passing of Senate Bill 144, the Department of Social Services contracted with Pennington County to establish an ARF.

During State Fiscal Year 2022, one-time general funds were used for the purpose of continuing to invest in ARFs. Through the Request for Proposal process, the following contracts were awarded for the purpose of construction of ARFs.

- Lewis & Clark Behavioral Health Services
- The Human Service Agency

Governor Noem's 2021 budget address included \$15,000,000 in federal funding from the American Rescue Plan Act funding to support the development and expansion of ARFs. For more information, see page 2.

During State Fiscal Year 2023, federal funding from the American Rescue Plan Act was used to support the development and expansion of ARFs. Through a Request for Proposal process, the following contracts were awarded.

Overview

Governor Noem's budget proposal includes \$15,000,000 in federal funding from the American Rescue Plan Act (ARPA) to support the development and expansion of regional behavioral health centers. South Dakota's current publicly funded behavioral health service model includes 11 community mental health centers and over 40 accredited substance use disorder providers serving geographic catchment areas. The current system provides a variety of treatment and prevention services but does not include a comprehensive crisis response model.

South Dakotans who are experiencing a behavioral health crisis are often met with law enforcement or Emergency Medical Services (EMS) response instead of stabilization services. Without comprehensive regional mental health supports in place, individuals in mental health crises are often involuntarily committed to inpatient psychiatric hospitals when they could be served in a less restrictive setting closer to their home and community.

Project Description

This project will further expand Appropriate Regional Facilities (ARF) as well as other behavioral health service capacities statewide. Recent investments in ARF in Yankton, Watertown, and Pennington County have created regional behavioral health centers that could integrate crisis stabilization, residential substance use treatment services, and transitional housing. This project includes funding for construction of new facilities or expanding/renovating existing facilities across the state.

Funding

Over the next four years, the state will commit a total of \$15,000,000 in ARPA funding to support this infrastructure development. To meet the needs of all regions, an estimated \$3,750,000 in ARPA funds will be spent each year for the construction and expansion of facilities across the state. In combination with the \$15,000,000 in federal funding, local funding will be needed to complete these service delivery changes.
