- 12. Are parents immediately notified regarding any serious injuries their child receives while under the care of the provider? 67:42:17:49
- 13. Are parents notified within 24 hours of any changes with the provider's registration such as a suspension, revocation, closure, or a change of location? 67:42:17:49
- 14. Does the provider and family day care assistant comply with their legal responsibility to immediately report any suspicion of child abuse and neglect to the child protective services, law enforcement or the State's Attorneys office? 67:42:17:47
- 15. Does the provider comply with their responsibility to report to the Office of Licensing & Accreditation within 24 hours any incidents or changes in circumstances that may affect their ability to meet registration standards? 67:42:17:06

- 16. Does the provider report to the Department of Health when a child in care contracts a communicable disease and follow their recommendations? 67:42:17:24
- 17. Are children who become ill while in the provider's care separated from other children, yet supervised, and parents notified of the illness? 67:42:17:24
- 18. Is written consent obtained from each child's parent before administering all prescription and non-prescription medication? Does the consent include the child's name, name of medication and the dates, times, and dosage of the medication to be administered? 67:42:17:27
- 19. Is medication administered to each child documented, which includes the child's name, dose, time, date given, and name of the individual administering the medication? 67:42:17:27
- 20. Is the medication documentation maintained for six months? 67:42:17:27
- 21. Are medications provided by the parent kept in their original container with the original label? For prescription medications, does the label include the child's name, instructions including the amount and frequency, expiration date, and physician or licensed practitioner's name? 67:42:17:27

- 51. Is there a fully charged, portable fire extinguisher, with a minimum 2A rating, kept in or within 15 feet of the kitchen or food prep area? 67:42:17:37
- 52. Is there an operating smoke detector with audible alarm located on each level of the home (regardless if level is used for care of children or not)? 67:42:17:37
- 53. If a fuel burning appliance is present in the home, is there a carbon monoxide detector installed according to the manufacturer's directions? 67:42:17:37
- 54. Is the hot water temperature at hand washing sinks used by children in care maintained at 120 degrees F or lower? 67:42:17:33
- 55. When children are in care, is the home's temperature maintained between 65-75 degrees F? 67:42:17:32
- 56. Are all walls, ceilings, floors, and equipment easily cleanable, kept clean and in good repair? 67:42:17:32
- 57. Are bathroom facilities easily accessible to children and providers? 67:42:17:33
- 58. Are toilets and hand sinks kept clean and in good repair? 67:42:17:33
- 59. Are hazardous cleaning supplies inaccessible to children and stored in their original container, used and disposed of in accordance with manufacturer's instructions? 67:42:17:44
- 60. Are soiled diapers promptly disposed of in a leakproof, non-absorbent container with a tight-fitting lid? 67:42:17:44
- 61. Is there a designated area for diaper changing that is easily cleanable and non-absorbent? 67:42:17:44
- 62. Is the diaper changing area cleaned and sanitized after each diaper change with a sanitizing solution approved by the department? 67:42:17:44

- 63. Are all bio-contaminants properly disposed? 67:42:17:44
- 64. Does each child over one year of age have a nap mat, blanket, or other sleep surface other than the floor to lie on during nap or rest periods? 67:42:17:26
- 65. If night-time care is offered, do children have a cot or bed for sleeping? 67:42:17:48
- 66. For children under one year of age, are safe sleep recommendations provided by the American Academy of Pediatrics followed which includes: placing infants on their back to sleep using a firm, flat, non-inclined sleep surface, and infants are not placed to sleep in equipment such as swings, bouncy seats, car seats, etc.? 67:42:17:26
- 67. For children under one year of age, is the sleep area free of soft objects and bedding including loose blankets, pillows, stuffed animals, bumper pads, sleep positioning devices, bibs, etc.? 67:42:17:26
- 68. Is bedding changed between use if the sleep environment is used by more than one child? (i.e., crib, pack-and-play, bed)? 67:42:17:26
- 69. Are all sleep surfaces maintained in good condition? 67:42:17:26
- 70. Does the provider, and anyone present in the home, refrain from smoking in the home when day care children are present? SDCL 34-46-14
- 71. Are the following hazards inaccessible to children: fire arms; pellet guns; BB guns; cap guns; ammunition; matches; lighters; tobacco products; items capable of being pulled or tipped onto a child such as a TV, shelf, dresser; sharp objects such as knives and scissors; small objects the size of a half-dollar or smaller that could present a choking hazard; or strangulation hazards such as dangling cords? 67:42:17:38
- 72. Are all unused electrical wall sockets covered with outlet plug covers, tamper-resistant covers or made inaccessible to children? 67:42:17:39
- 73. Are portable space heaters, fireplaces, and wood burning stoves inaccessible to children when in use? 67:42:17:37
- 74. For each level of the home used for the care of children, are there 2 unblocked exits separate and remote from each other? 67:42:17:37
Note: Window wells or outside structures of building etc. cannot inhibit or prevent exiting.
- 75. If windows are used as a second exit, does the window provide a clear opening that is at least 20 inches wide and 24 inches high and 5.0 square feet in area to ensure a person can exit from the window, and easily opened from the inside to allow evacuation? 67:42:17:37

- 76. Are all open-sided floor and wall openings, and platforms inside & outside the home which are more than 30 inches above ground level, guarded by a barrier that is at least 36" tall and no more than 5" between openings? 67:42:17:38
- 77. Are all pets confined and kept away from children if there is a history of aggression? 67:42:17:40
- 78. Is there documentation showing pets have current vaccination records? 67:42:17:40
- 79. Are pet's living quarters clean and sanitary? 67:42:17:40

- 80. Is the outside play area safe, in good repair, and free of debris, trash, weeds and hazardous material? 67:42:17:35
- 81. Is the playground equipment installed according to the manufacturer's instructions and in good repair? 67:42:17:35
- 82. Are all play areas which are near an area that is dangerous or life-threatening that could pose a risk of a serious injury to children enclosed with a fence that is at least 42" high? 67:42:17:35 Note: This includes but is not limited to pools, water filled ditches, high traffic areas, etc.
- 83. In areas where any bodies of water are present, is the provider outside and able to see and hear the children, and close enough to intervene at all times? 67:42:17:36 NOTE: This includes but is not limited to pools, wading pools, and water filled ditches.
- 84. If a wading pool is used, is it drained after each use? 67:42:17:36
- 85. If a pool is used, but not drained after each use, is there a five foot fence or barrier surrounding all sides of the pool and a latched gate restricting access into the pool area? 67:42:17:36
- 86. If a hot tub is present, does it have a secure cover? 67:42:17:36
