

SHARED PARENTING CHILD SUPPORT OBLIGATION WORKSHEET

This worksheet is to be used when each parent provides a suitable home for the child, the court order allows the child to spend at least 180 nights per calendar year in each home, and both parents have agreed in writing to share the duties, responsibilities and expenses of parenting, including any expenses for the child's education, recreation and entertainment activities. Federal Income Tax (FIT) deductions are based on one withholding allowance for a single taxpayer (see attached page for amount to use). For unemployed or less than minimum wage, use \$1,411.00 for Gross Income. If disabled, use actual amount of benefits. All amounts listed must be **MONTHLY**.
