COURSE IN SCIENTIFIC/PROFESSIONAL ETHICS AND STANDARDS: Example: PSYC 701: SEMINAR – ETHICS AND PROFESSIONAL ISSUES (3 credits)

COURSE IN RESEARCH DESIGN AND METHODOLOGY: Example: PSYC 771: RESEARCH DESIGN AND STATISTICS I (3 credits)

COURSE IN STATISTICS AND PSYCHOMETRICS: Example: EDER 862: MULTIVARIATE STATISTICS (3 credits)
