reinstatement of my license to practice psychology in South Dakota.

That I make this voluntary surrender with full acknowledgment  
of my legal rights, and following extensive consultation with

counsel of my choosing, and otherwise being fully advised in the premises.



That I am aware of current proceedings pending which I assume by my action will be dismissed. The allegations by the Complainants made against me primarily cover or refer to matters unrelated to my practice of psychology, have been previously litigated in civil court and resolved, my previous counsel have purged their files and I have long since discarded records and documents related to my contact with some of these individuals, said contact ten, fifteen, and indeed twenty years ago, effectively depriving me of the ability to reasonably defend myself.


I make this voluntary surrender of my own free will, and intend the same to be a knowing and voluntary permanent relinquishment of my right to practice psychology in the State of South Dakota.


