




# South Dakota Medicaid Access to Dental Care

# Dental Services Overview

Delta Dental of South Dakota adjudicates South Dakota Medicaid dental and orthodontic claims.

South Dakota Medicaid covers the following dental services for both children and adults:


- Two exams/year
- Two cleanings/year
- X-rays
- Sealants
- Silver Diamine Fluoride
- Fillings
- Extractions
- Root Canals
- Children's coverage includes orthodontia in cases of extreme medical need.
- Adult dental coverage is limited to \$2,000 per plan year with some services exempt from the max.

# Goal 1

Increase the percent of SD dentists enrolled in Medicaid by 5%.

Strategy: Build upon recent SD Dental Association campaign by discussing recent policy changes and positive aspects of participation with non-participating providers.


## Recent SD Medicaid Policy Enhancements




# Goal 1

# Goal 2

Strategy: Published a provider toolkit with strategies for managing missed appointments as missed appointments are often cited by dentists as a challenge.




# Goal 2

**Goal 3:** Increase the percent of recipients that receive any dental services by 10%.


**Subgoal:** Increase the percent of eligible children and adults that receive any preventative dental services by 10%.

Separately Tracked:

- Cleanings
- Periodic or Comprehensive Evaluations
- Fluoride Varnish in a dental setting
- Sealants


# Goal 3

Increase the percent of enrolled adults that receive any dental services by 10%.



# Lessons Learned

- Several access related initiatives had been completed before this pilot project.
- A major dental fee increase in July 2023 left little room for initiatives related to reimbursement during this project. The department also does not control the funding level for services as funding is appropriated by the legislature.
  - A survey of non-participating providers showed that the top request is still higher reimbursement.
- Workforce remains a major challenge to achieving access-related goals.
