**Re: Substance Use Disorder Treatment Services Provided in an IMD**

South Dakota Medicaid was previously able to cover medically-monitored intensive inpatient treatment program services provided to eligible individuals who were patients in an eligible Institutions for Mental Disease (IMD). The law that allowed for this coverage sunset on September 30, 2023, which resulted in Medicaid coverage of the services ending. This bulletin is to notify providers that Medicaid coverage is allowed to resume due to the passage of the Consolidated Appropriations Act (CCA) of 2024, which provided a permanent Medicaid state plan coverage option.

Effective June 1, 2024, medically-monitored intensive inpatient treatment program providers must bill for services for Medicaid eligible recipients to Medicaid.

**Enrollment Record Update**

To resume billing Inpatient SUD IMD services under taxonomy code 324500000X to South Dakota Medicaid, providers will need to modify their Provider Enrollment Record.

To update the enrollment record, take the following steps:

- Login to the [Provider Enrollment Portal](#).
- Click the update button.
- Under Taxonomy Code populate “324500000X”, and enter the effective date of 06/01/2024, leave the end date blank.
- Review the rest of the enrollment record and update any other necessary information.
