**Re:** Provider Enrollment Claim Submission Extension

South Dakota Medicaid is **extending the claim filing time limit for providers with a provider enrollment or modification approved by South Dakota Medicaid since November 1, 2021.**

Providers with approval notices dated November 1, 2021 or later, will have until June 30, 2022, or six (6) months from the date of the approval notice to submit claims prior to the date of approval; whichever is later.

Providers must upload or attach a copy of the provider enrollment approval notice showing the NPI and date received to each claim that exceeds normal timely filing limitations. This will provide South Dakota Medicaid staff with the necessary documentation to override timely filing requirements when appropriate. Providers may submit claims previously denied by South Dakota Medicaid for timely filing if the original filing was on or after November 1, 2021.
