

## SDCL 28-6-1.2 Chiropractic Services Reimbursement Information

The following is an analysis of Medicaid's state fiscal year 2023 chiropractic fee schedule rates. The rates are compared to Medicaid's target reimbursement methodology, surrounding state Medicaid agency rates, and charges billed by Medicaid providers. The billed charges analysis only includes claims that were paid in state fiscal year 2022 and that Medicaid was the primary payer for.

### Definitions

"Target Reimbursement"	Information regarding the current methodology used to calculate reimbursement rates.
"Percent of Target"	A comparison of the Medicaid rate to the target reimbursement rate. This is arrived at by dividing the Medicaid rate by the target rate.
"Percent of Average Billed Charges"	A comparison of the Medicaid rate to the average billed charges submitted by providers. This is arrived at by dividing the Medicaid rate by the average billed charge amount.
"Percent of Surrounding State Rates"	A comparison of the Medicaid rate to states Medicaid agency rates for states that border South Dakota. The surrounding state rates billed charges submitted by providers. rate arrived at by dividing the Medicaid rate by the target rate.
