This resource provides data related to services provided by the Department of Social Services, Office of Licensing & Accreditation (OLA) and Child Care Services (CCS). The information is related to licensed for-profit and/or nonprofit centers and before and after school programs, and family child care homes voluntarily choosing to be registered with OLA.
